## ●Rules & Important Information●

1. This is a juried event. Pictures or samples must be submitted and must represent actual items to be sold at the show. Pictures must also demonstrate how the items are crafted by exhibitor. Digital photos or web links may be e-mailed [mac-marq@alpinecom.net](mailto:mac-marq@alpinecom.net) Printed photos and samples may be sent to address above. These items will be returned to you at time of registration. If you wish to receive your items prior to the event please include a self-addressed, stamped envelope.
2. Sales tax is 7%; McGregor is in Clayton County (#22)
3. All exhibitors must have an Iowa State sales tax number on file in our office. If you do not have an Iowa Tax ID number the Chamber of Commerce will provide you with a temporary permit at the time of registration. Vendor records are submitted to the IA Department of Revenue after every show. For a permanent sales tax number, please contact the Iowa Department of Revenue and Finance at 515-281-8966.
4. The show is held rain or shine. No refunds will be granted. If you must leave early, please contact the organizer with the reason. Early, unapproved tear-downs are not permitted.
5. All spaces are 10' x 10'. If your canopy is larger, you will need to rent additional space. All merchandise must be inside your assigned space. Measurements are as accurate as possible. Spaces may not be level or perfectly square. Be prepared to set up and work around obstacles. Be prepared to set up on grass or blacktop.
6. Requests must be written on your registration form. Every attempt will be made to fulfill your request but **NO REQUEST IS GUARANTEED**. Space assignments are final.
7. **ALL ITEMS MUST BE HAND CRAFTED BY THE EXHIBITOR**. Jurors will visit each booth prior to event start. Exhibitors will be asked to remove products which were not pre-approved. We reserve the right to dismiss vendors from the show if found to be noncompliant with this rule and no refund will be given.
8. Vendor registration takes place at the Chamber office (146 Main St., across from Triangle Park) Set-up may begin after **NOON** the Friday prior to the event and by 8:45 a.m. Saturday. For ease of set up, all exhibitors are to **MOVE IN, UNLOAD, AND MOVE OUT** to the free city parking area, south of Triangle Park. All vendors will be required to park in the city parking lot as Main Street parking is intended for your customers only.
